When your baby's first tooth comes in (or no later than their first birthday), take them to the dentist.



Quality Measures

The AAPD recommends linking children to a Dental Home by age 1 or the eruption of the first tooth.

We do that at KinderSmile Foundation.

However, as a state we are failing our families!

The quality measures released show that

- By age 1 less than 1% of children see a dentist
- At age 2-3 only 22% have preventive care
- At age 3-5 only 50% do

The average for all ages was 44%



Oral Health Data

In **2023** the New Jersey DOH collected oral health data for the first time:

• **36%** of all NJ 3rd graders had untreated dental disease, compared to the national average of 20%.

• **24%** of NJ's Head Start children have untreated decay, compared to 12% nationwide.

• On any given day **15%** of NJ's 3rd graders need **URGENT** dental care.

Importance of Oral Health

Keeping Your Child's Smile Healthy

All children are at risk for tooth decay and gum disease. Both are preventable and you can play a key role in your child's oral health. Healthy "baby" teeth and permanent teeth are important to your child's overall health and wellness!



Take your child to the dentist by their First Birthday

- All children should visit the dentist when their first tooth comes in.
 Seeing the dentist to prevent disease helps keep your child healthy.
- Their pediatrician can give a referral to the dentist at your regular visit and must refer your child to the dentist by their first birthday.
- Your child should visit the dentist twice a year. These visits include an oral exam, X-rays if needed, and preventive services that include cleaning, a fluoride application and instructions to parents/caregivers on how to keep your child's teeth clean.
- Make and keep scheduled dental visits and make sure that all needed treatment is completed.

Dental Services for Children in NJ FamilyCare

Your child should have a dental home. A dental home is where your child receives all of their dental care in a compassionate, caring, family-focused setting. Your NJ FamilyCare health plan will work with you to find a dental home for your child by their first birthday. Please call the Dental Benefits number on your 1.D. card or visit your health plan's website for assistance.

Your child cannot have good overall health without good oral health.

 Oral Evaluations (including oral hygiene instructions), Fluoride varnish and Cleanings with fluoride can be provided twice a year or more frequently based on medical necessity and for children with special health care needs.

- A prescription for fluoride supplements may be given by either your dentist or primary care provider (PCP) to help prevent cavities.
- *The application of fluoride varnish to protect teeth from cavities can also be done for children through the age of 5 by their PCP followed by a referral to the dentist for an oral evaluation, X-rays as needed, cleaning and dental treatment.
- A Carries/Cavities Risk Assessment should be done once a year to determine your child's risk of developing cavities. The visit includes an oral evaluation, instructions on brushing, oral health, safety and nutritional counselling to parents/caregivers and children.
- Sealants and repairs of sealants should be provided to premolars and permanent molars of children between the ages of 6 through 16 to help prevent cavities
- Dental treatment services for primary "baby teeth" and permanent teeth include: fillings, stainless steel crowns, treatment for toothache and extractions and should be provided when recommended by your child's dentist.



Dental Care Access Required in NJ FamilyCare MCO Contract

Provider Directory Requirements: Separate listing of dental providers who provide dental services to members under the age of six ; These listings shall be updated as needed and at a minimum quarterly. (section 4.8.4.c)

Include and make available sufficient number of primary care dentists; Pediatric dentists shall be included in the network and may be both primary care and specialty care providing primary care ratio limits are maintained. (section 4.8.8.A.2).

For dental appointments, be able to provide routine non-symptomatic care and/or specialist referrals within twenty-eight (28) days of member request. (section 5.12.N)


The Flow Chart to the left is the shifting of financial risk, but *responsibility to the children* remains with the state and MCOs.

Quality Institute Secret Shopper Research Questions

Q1: Of the practices listed in Medicaid Managed Care Organization (MCO) dental provider directories as serving children aged 0-6, what percentage offer appointments for patients in this age group?

Q2: Of the practices listed in the MCO provider directories as serving children aged 0-6, what percentage of the information listed is accurate?





The MCO 0-6 directories were accurate **49%** of the time regarding **providing care for a 2-year old**.

51% of the time the practice said they **did not schedule appointments** for **2-year olds**.

Results



Of the practices listed in the MCO 0-6 directories reported that they **were innetwork with the the MCO** at the time of the call.

The balance of the time, **(37%)** the practices reported they did **not accept that insurance**.



Patient Access Areas of Concern

Providers with waiting lists of 6 months long.

Providers with waiting of 300+ names long.

First appointments are exams only, not cleanings. Overall, provider representatives on the phone have common misconceptions about what age is appropriate to begin seeing a dentist.



0-6 Year Old Network Directory Areas of Concern

51% listed on the 0-6directory do not accept children aged 2 years old 37% listed do not accept the insurance for which they were listed in that MCO 0-6 directory 14% of practices were unreachable, with no answer after two attempts to call; 4% couldn't be reached because the wrong number was listed

Appointment Availability: Average Wait Time: 31.54 days

Secret Shopper Methodology

Script Design:

Created a script for scheduling dental appointments, including specific questions and responses.

Practice Selection:

Chose practices from all five Medicaid MCO Directories of Dentists Treating Children under the Age of 6. Only general and pediatric dentists were chosen (824). This included FQHCs.

Process:

All 824 practices were called.

Attempted to schedule an appointment for a two-year-old child.






Category	Definition
Number of Listed Practices	Number of offices from all MCO directories that "Accept patients 0-6 years old" that are listed as either pediatric dentistry or general dentistry.
Reached Practices	Percentage of offices that were called that answered the phone and were able to respond to questions.
Unreachable Practices	Percentage of offices called that did not answer after repeated attempts (at least two calls).
Incorrect Phone Number	Percentage of offices that were unreachable due to an incorrect phone number listed on the directories.
Actual Matches Directory for Age	Percentage of offices that were able to accept appointments for patients ages 2 and up.
Actual Matches Directory for Insurance	Percentage of offices that accepted the MCO insurance used during the call, selected randomly from the list provided.
Offering Multiple MCOs	Percentage of offices that accept multiple MCOs, extracted from the MCO directory listings.
Not Accepting New Patients	Percentage of offices that stated that they were no longer accepting new patients during a call.
Hold Time	Maximum average wait time for calls that placed our researchers on hold.
Average Appointment Date Distance	Average length of time until an available appointment.
Median Appointment Date Distance	Median length of time until an available appointment.






Number of Dental Practices Listed in 0-6 Directories by County


Percentage of the 0-6 Directory Listings With Accurate Information That Practice Provides Dental Care for Two Year Olds


